Regular Township Board Meeting November X, 2016

1) Call to Order

The regular meeting of the Woodhull Township Board was called to order at 7:00 pm on November 2, 2016 by Supervisor Hasse.

- 3) Roll Call
  Present at this meeting were: Supervisor Hasse, Clerk Masters, Treasurer
  Cribbs, Trustee Brehm, Trustee Dodge.
- 4) Approval of Agenda Moved by Treasurer Cribbs, supported by Trustee Dodge to accept agenda with the following changes: 5) Appoint Jan Holyfield **Acting Secretary** for the purpose of taking minutes and 6) Approval of Minutes--**October 5**, **2016**. **All Ayes, Motion carried unanimously**.
- 5) Appoint Acting Secretary Jan Holyfield to take minutes. Approved.
- 6) Approval of Minutes October 5, 2016 Moved by Trustee Dodge, supported by Trustee Cribbs to approve the minutes from the October 5 regular board meeting. Motion carried unanimously.
- 7) Board Comments and Reports
  - a. Trustee Brehm Planning Commission Report
     The Planning Commission met October 25 to consider the Special Land
     Use Request--#PSUP16-11, Skyway Towers/Verizon. After discussion

and with several stated contingencies, the Planning Commission voted unanimously to recommend the request to the Woodhull Township Board.

- Trustee Dodge Fire Report
   Trustee Dodge presented the Fire Report for October 2016.
- c. Clerk Masters
  - i. Monthly Bills Supervisor Hasse moved, supported by Trustee Brehm, to approve the monthly Bills as proposed totaling \$47,515.43. A Roll Call Vote was taken. All Ayes. Motion passed unanimously.
- d. Treasurer Cribbs Financial Report
  Treasurer Cribbs reported that all normal bills had been paid. Nonnormal expenses for the month were Removing Beaver Dam \$500.00,
  Legal Fees \$16,069.50, and Roadwork/Paving for \$173,319.25.
- e. Supervisor Hasse No report
- 8) Public Comment Limited to 3 minutes per person for new business only. Andy Webber of Skyway Towers/Verizon presented specifications for the additional cell tower to be located near Braden and Dunn Roads. He answered questions regarding the proposal as to coverage and design.
- 9) New Business
  - a. Planning Commission recommendation for PSUP 16-11 Skyway Towers/Verizon Wireless--property owner F. James & J. Charlene Houghton.

Following discussion of the recommendation and Mr. Webber's presentation, **Trustee Brehm moved**, **seconded by Trustee Dodge to approve the recommendation by the Planning Commission for an additional cell tower to be located near Braden and Dunn Roads. Approved unanimously.**
