Regular Meeting

March 5, 2014

Supervisor Slee called the regular monthly meeting to order at 7:00 p.m.

Present were: Clerk Maize, Treas. Cribbs, Trustee Brehm & Trustee Dodge.

Pledge of Allegiance was given.

Brehm moved and Slee supported to approve the agenda as amended to reverse number 1 & 2 on the agenda. Motion carried.

Cribbs moved and Slee supported to approve the minutes as written for the February 5, 2014. Motion carried.

Treasurer's report for February was accepted subject to audit.

DELEGATION OF VISITORS:

COMMITTEE REPORTS:

Trustee Dodge presented the Board with an update on the Fire and Ambulance. Total runs for the year: Fire 99 and Ambulance 67.

Trustee Brehm reported that a Planning Commission meeting was held and the only topic up for discussion was to set the budget for 2014-15.

CALL TO PUBLIC: Opened at 7:06 p.m. There were several residents at the meeting and comments were directed towards the Scenic Lake Road Project. Both sides (for and against were heard) and one letter was received and asked to be read. Closed at 7:45 p.m.

ACTION ITEMS:

Brehm moved and supported by Slee that all subdivisions in Woodhull Township, as per past practice, be responsible for establishment, maintenance and repair of their

respective facilities including their streets/roads. Roll call vote was taken. Brehm, yes; Maize, yes; Slee, yes; Cribbs, no and Dodge, no. Vote was 3-2. Carried.

Cribbs moved and supported by Dodge to direct the Supervisor to spread the levy for the Scenic Lake Special Assessment for Roads at .003% over a 5 year plan. Roll call vote was taken. Cribbs, yes; Brehm, yes; Dodge, yes; Maize, no and Slee no. 3-2 vote. Cribbs rescinded this motion and agreed to a motion by Maize and supported by Slee to table the motion until the actual figures could be obtained from the Road Commission. Motion to table carried.

Slee moved and supported by Brehm to not collect the Township Operating Millage and all the Admin Fees for the 2014 tax year if found to be a legal action to take. Roll call vote was taken. Maize, yes; Brehm, yes; Cribbs, yes; Slee, yes and Dodge no. 4-1 vote. Carried.

Dodge was concerned if it was legal to do and didn't feel comfortable voting yes if it was something the Board couldn't legally do. Slee will contact Township attorney for legal advice on this motion.

Budget workshop has been set for March 19, 2014 at 10:00 a.m. at the Township Hall and the Annual Budget Hearing will be held on March 25, 2014 at 10:00 a.m. at the Township Hall with a Special Meeting following the Budget Hearing.

Brehm moved and supported by Dodge to pay the bills as presented. Motion Carried.
