Maize moved and supported by Brehm to adopt a resolution to appoint the Supervisor as the Freedom of Information Act coordinator. Roll call vote was taken. Dodge, Cribbs, Brehm, Maize & Slee ayes. No nays. Motion carried.

Brehm moved and supported by Cribbs to adopt by resolution the Woodhull Township Master Plan as written and presented by the Planning Commission. Roll call vote was taken. Cribbs, Dodge, Maize, Brehm & Slee ayes. No nays. Motion carried.

Dodge moved and supported by Cribbs to hold public hearings for the Ambulance Special Assessment. Motion carried. They will be held in the months of September & October.

Cribbs moved and supported by Maize to collect the Haslett Summer School property taxes for 2013. Motion carried.

Brehm moved and supported by Cribbs to pay the bills as presented. Motion carried.
