2019 DOG LICENSE

Dog licenses are due by Feb. 28, 2019 for the following fees: Un-neutered (either sex) \$30.00. Neutered \$10.00. After Feb 28 the license may be purchased at the County Treasurer's office. Delinquent license fees are \$60.00 (non-neutered) and \$20.00(neutered). Any animal (4) months or older by Feb. 28 **must** have a license.

If you purchased your dog license anywhere within Shiawassee County for the same dog last year, we will have the information we need for the new license in our computer. You need only fill out the application if any information has changed from last year, or if purchasing a license for the first time in Shiawassee County. Please send or bring with you all proof of current rabies vaccination by an accredited veterinarian, proof of sterilization or neuter if applicable, and the form if needed. 2019 WOODHULL TOWNSHIP WINTER TAX COLLECTION

The tax information for Woodhull Township is now available on-line. It can be accessed through www.bsasoftware.com. There may be an inquiry fee.

ESCROW ACCOUNTS: All tax bills are being mailed to property owners only. It is the property owner's responsibility to forward their tax billing to their own mortgage company. We only mail the bill to the property owner because of the constant change of lending institutions, wrong parcels paid on, duplicate payments from escrow companies, title companies and homeowners, etc. This will enable the property owner to know exactly how much is being paid from their escrow accounts.

Taxes may be paid by mail or by leaving the payment in the drop box labeled 'MAIL' next to the office door. **DO NOT LEAVE CASH IN THE DROP BOX FOR YOURS AND MY SAFETY.**

Please enclose tax notice (top half), and check, money order, or bank draft made out to: Woodhull Township Treasurer and mail to P.O. Box 166, Shaftsburg, MI48882. No receipt will be sent. The bottom of your statement will act as your receipt along with your cancelled check. If you want a receipt, please enclose a **self-addressed envelope** - - - -

PLEASE PAY BY PERSONAL CHECK, MONEY ORDER, OR BANK DRAFT. (If you must pay by cash, please have the correct amount as I do not have change on hand.) We will not make refunds for any overpayments less than \$5.00. We do not accept credit cards.

If you would like to pay your taxes in person, I will be at my office adjacent to the town hall at 7315 W. Beard Rd, Shaftsburg, at the designated times and dates below. Please bring your tax notice with you. The last day to pay taxes without a penalty is February 14, 2019. After this date, the tax, 1 % interest and a 3% penalty are due through February 28, 2019. Starting March 1, 2019 taxes must be paid at the Shiawassee County Treasurer's office in Corunna and a 4% county admin fee (\$1.00 minimum) and 1 % interest per month will also be charged.
