Meeting called to adopt the final budget for the 2018-2019 fiscal year along with the Cemetery Fund, Banks, Fire and Ambulance Resolutions, Board Meetings, Perpetual Care Fund, transfers as needed and any budget adjustments for the 2017-2018 fiscal year, public comments.

## **DECISION ITEMS:**

**AMEND THE** 2017-2018 budget to reflect the revenue and expense adjustments. Jelenek moved and Betts supported to adjust the revenues to \$534,482.00 and the expenses to \$465,621.00 with a net of \$68,861, pending audit. Roll call vote take. Nickols, yes; Betts, yes; Maize, yes; Jelenek, yes. All ayes and no nays. Motion carried.

FINAL BUDGET – Betts moved and supported by Nickols to adopt the 2018-2019 General Fund budget with corrections by Activity Center with the Clerk authorized to transfer within activity center. This is our Appropriation Act and can be revisited at a later date. Roll call vote. Jelenek, yes; Betts, yes; Nickols, yes and Maize, yes. All ayes and no nays. Motion carried

BANKS – Jelenek moved and supported by Betts to continue to use the banks we use now with the possibility that new banks can be added. Banks being used are PNC, 5/3 Bank, Citizens/Huntington Bank, Capitol National & Horizon. Roll call vote was taken. Maize, yes; Betts, yes; Nickols, yes and Jelenek, yes. All ayes and no nays. (5-18) FIRE AUTHORITY RESOLUTION – Maize moved that we resolve to hereby amend the Woodhull Twp Budget for the 2017-2018 fiscal year with regards to the Fire authority millage which is a special assessment revenue fund with our budget revenue anticipated to be \$127,303 and our expense to the Fire Authority millage anticipated to be \$127,303.00.
