- c. <u>Supervisor Nickols</u> Supervisor Nickols presented Park Board Chairman Fred Kline with 35 years of service plague. Thank you for the dedicated work to Woodhull Township Park! The Shiawassee County Board of Commissioners, Zoning Board of Appeals has a vacancy to be filled.

## **Committee Reports:**

**Fire & Ambulance:** Presented by Fred Kline: The LSW report for September 2020 had 24 Fire/Rescue and 20 Ambulance for Woodhull Township. Total of all LSW runs for 2020; Fire 494, Ambulance 323. Starting November 1, 2020 James Betts became the active Fire Chief. Trustee Jelenek asked for budget purposes in the next few months, how much more is the advanced life support affect budget needs and should there be an increase be looked into. **Planning Commission:** Presented by Rick Betts: The Planning Commission Board voted to deny recommendation of PSUP20-09 Dog Kennel.

<u>Park Commission:</u> Presented by Fred Kline: The walking trail was repaved. The edges will be completed soon with black dirt to even out sides. Signs were replaced and or repainted. Spring toys were put up for the winter. One picnic table left out for park visitors.
