Motion by Secretary Palmatier to move \$350 from Miscellaneous budget to Capital outlay and \$375 from Maintenance budget to Capital outlay, for a total of \$725 being moved. Motion supported by Trustee Hill. Roll call vote: Provines – aye, Bawks – aye, Bell – aye, Hill – aye, Palmatier – aye

Motion by Trustee Bell to accept the financial report, supported by Secretary Palmatier. The motion passed with 5 votes in favor.

Park Facilities Manager report. Jerry got estimates for all of the work needed to be done to address the tree with 3 codominant stems that partially fell by the back ballfield, damaging the fence and gate. .

Motion made by Trustee Bell for Jerry to contact J&J Tree Service to start the process to remove the cherry tree that has fallen at the back ball field, along with the 2 stems that are still standing. We will use any funds we have remaining from the 2022/2023 budget, and Park savings, as necessary, with the intent that it will be replaced after we get our budget for 2023/2024. Next fiscal year there will be a motion to put the money back in Park savings after we have a 2023/2024 budget. Motion was supported by Treasurer Bawks.
