Approval of agenda. Trustee Bell made a motion to accept the agenda with 2 changes: Move item "Update on Property" up on the agenda and add a new item "Update from Clerks office". Trustee Hill seconded the motion. Motion passed with 5 votes in favor.

Approval of August 14, 2023 minutes. Trustee Bell made a motion to accept the minutes as written, supported by Trustee Hill. The motion passed with 5 votes in favor.

Update on Property. This morning, September 11, 2023 there was a meeting at the township office where the Quick claim deeds were signed by Supervisor Slee (who is authorized to sign on behalf of the township) and Kathy Pope (property owner). Attorney Bowne and Chairman Provines were also in attendance. The last step is to turn in signed **Property Transfer Affidavits** (PTA) to the Accessors office. Diane Dowler is going to draft these PTAs and email them to Supervisor Slee and Chairman Provines, who will get Kathy Pope's signed. Fence modifications are scheduled to start September 25.

Budget/financials presented. We balance except for 2 outstanding issues Treasurer Bawks has been working to have addressed: We have \$736.96 of last year's bills that were paid out of this year's budget. They were paid after April 1 so they came out of this year's budget, leaving us a shortage this year. Per BS&A, we are still waiting for the \$1,967.89 balance from last year to be transferred to our savings account. Treasurer Bawks will talk to Township Treasurer Warfle about this.

July emergency tree removal. Motion made by Secretary Palmatier to approve the move of \$1,600 from Capital Outlay Miscellaneous line to Maintenance line, and to approve payment of the \$6,000 bill for tree removal. The motion was supported by Trustee Hill. Roll call vote: Provines – aye, Bawks – aye, Bell – aye, Hill – aye, Palmatier – aye

Park reservations. We have 2 pavilion reservations for September.

Park Facilities Manager report. The fence work is scheduled to begin on September 25. It will probably take multiple visits by Spartan Fence and there will be times the park will need to be closed. The county is now telling Jerry they have not hired an arborist but did provide a list of arborists in the county. We'll review that list and find someone to help with tree evaluation.
