Approval of agenda. Treasurer Bawks made a motion to accept the agenda. Trustee Hill seconded the motion. Motion passed with 4 votes in favor.

Approval of September 11, 2023 minutes. Treasurer Bawks made a motion to accept the minutes as written, supported by Trustee Hill. The motion passed with 4 votes in favor.

Approval of Budget/financials. October payroll was done through BS&A. Twenty five (25) dollars cash was paid by Sean Smith for a pavilion rental for July 28, 2024 (next year). Treasurer Bawks is going to record the reservation but return the money for now, as we can't deposit next year's revenue yet. We have \$14,903 in Capital Outlay and will have \$5,400 after the bill for the fence work is paid. We are waiting for the attorney's bill from work done on straightening out the property. Motion made by Secretary Palmatier to accept the financial reports, supported by Trustee Hill. The motion passed with 4 votes in favor.

Park Facilities Manager report. Spartan Fence did great work for us, working out issues that came up. Jerry will get estimates for blacktop work to finish up what needs to be done for the relocation of the gate. The county was not able to help us with an arborist. Next year's budget to include funds for finishing the timbers and chips around the remaining benches.

Approve bills for payment. Motion made by Treasurer Bawks to approve paying the park board for today's meeting. The motion was supported by Trustee Hill. Roll call vote: Provines – aye, Bawks – aye, Bell – absent, Hill – aye, Palmatier – aye

Park Closing. Jerry does not need a board workday to close the park down. He'll get someone to come over and spot him while he climbs ladder, etc.
