Approval of agenda. Treasurer Bawks suggested adding 2 topics to the agenda: Meeting start time change and Review Arborist report. Trustee Bell made a motion to accept the agenda with the 2 additions. Treasurer Bawks seconded the motion. Motion passed with 5 votes in favor.

Approval of October 16, 2023 minutes. Trustee Bell made a motion to accept the minutes as written, supported by Treasurer Bawks. The motion passed with 5 votes in favor.

Approval of Budget/financials. Treasurer Bawks presented the financial and budget reports. She still needs to return Sean Smith's pavilion rental fee. She provided a review of the projected expenses vs budget for the rest of the year, and we look on track. The arborist bill was \$700, so that was under what we had approved/expected. Motion made by Secretary Palmatier to accept the financial reports, supported by Trustee Bell. The motion passed with 5 votes in favor.

Park Facilities Manager report. Jerry went through the park with the arborist, and the arborist report has been received. He will be meeting with the asphalt contractor to get a price for the changes to the driveway.

Discuss our meeting start time change. We will change our meeting start time to 6:30pm for the remaining meeting dates this year and next.

Review arborist report. The Visiting Arborists evaluated the trees in the park. Ten (10) were identified for removal and four (4) were said to need pruning attention. Jerry will review the trees with Bill to determine what they can handle and what we'll need to hire out, so we have that information for budget planning.

Motion made by Trustee Bell to approve paying Jerry for a 3<sup>rd</sup> week of work in November. The motion was supported by Chairman Provines. Roll call vote: Provines – aye, Bawks – abstain, Bell – aye, Hill – aye, Palmatier – aye

Motion made by Trustee Bell to budget up to 4 hrs. at \$15/hr. for Bill to evaluate the work needed to address the tress identified by the arborist. The motion was supported by Secretary Palmatier. The motion passed with 5 votes in favor.
